A collar with the dog's registration disc attached must be worn by your dog when it is in a public place. This doesn't apply to assistance dogs.  If owners want to keep more than 2 dogs or 4 working dogs on premises, you must obtain and maintain a licence to keep several dogs.  A certificate from an authorised veterinarian stating that the dog has been microchipped, desexed or a tattoo on ear symbol is only accepted as evidence at Council reception. Also, evidence must be provided to prove that your dog is a working dog.
